MEALS

NYFRF recommends that Legislative Day attendees purchase breakfast items before entering the Capitol Complex or at one of the Concourse cafeterias before the event. You are welcome to bring food and beverage items into the Convention Center. Coffee, tea and water will be provided in the convention hall throughout the event. A box lunch (sandwich or salad, chips, cookie and bottled water) can be pre-purchased for \$15.00. If you do not want to purchase a box lunch you may either find lunch at one of the concourse cafeterias or bring your own from home.

CAPITOL SECURITY AND PARKING

NYFRF recommends parking in the garage located beneath the Empire State Plaza in the V-Lot. This parking area is accessible through the I-787 Empire State Plaza exit. Visitors are required to show photo identification upon entry and (though rare) all vehicles are subject to search by the State Police. The parking fee is \$10 per vehicle. Plan to arrive before 8:00 AM to find adequate parking. Additional parking information is available at NewYorkFamilies.org.

LEGISLATIVE DAY REFUND POLICY

Upon request, NYFRF will provide refunds to persons who have purchased tickets for Legislative Day, providing that the refund request is communicated to our office no later than seventy-two (72) hours prior to Legislative Day. NYFRF does not provide refunds based upon inclement weather, as our financial obligations for Legislative Day (including the cost of renting the Empire State Plaza Convention Center) remain the same regardless of weather conditions.
